GUIDANCE ON APPLYING FOR A SPECIAL EXAMINATION CENTRE

If you are an overseas candidate in an area other than those listed on IRM's website, you may make an application to IRM to arrange a special examination centre. Applications must be made on this form and submitted to IRM by 28 February for the June examinations and by 31 July for the November examinations. Applications received after the specified deadline will not be considered.

Selecting a special centre

It is essential that the facilities and invigilation services offered by a special centre are of the same standard as that offered by IRM's regular examination centres. You must therefore utilise the services of the British Council wherever possible. A local school, college, university, or other organisation will only be considered if it is not possible to use British Council facilities.

Submitting an application

Before submitting your application form, you must first contact the proposed special centre to confirm their availability and willingness to act as an examination centre.

It is your responsibility to ensure that Section 2 of the application form is completed and signed by the Presiding Officer of the proposed special centre.

Fees and other charges

A special centre fee of £50 is payable to IRM and must accompany the completed application form. The fee can be paid by cheque, BACS transfer or credit card. In addition, all charges made by the special centre in connection with the examinations are your responsibility and you must pay these directly to the special centre.

Approval

On receipt of a completed application form, IRM will undertake security checks with the proposed special centre to ensure that the venue is suitable and that candidates will sit their examinations under strict examination conditions. If we decide that the proposed special centre is unacceptable we will contact you and ask you to seek an alternative centre. We will also contact you to let you know that if your application has been approved.

The Institute reserves the right not to approve a special centre request.

Examination withdrawal and non attendance

If you withdraw from or fail to attend, an examination at an approved special centre you may be liable to the special centre for any costs incurred. Your special centre fee to IRM is non-refundable.
